



## 2022-2023 Variable Tuition Guidelines

About Variable Tuition at Southeast Christian School:

Variable Tuition is:

- Based upon needs of applicants (both custodial and non-custodial parents) and availability of funding.
- Given for one year at a time. Families may re-apply if the need persists.

Who is eligible:

- Existing families of students in PS-8 in good academic, attendance, behavioral, financial and volunteer standing who have completed enrollment.
- New families with students in PS-8 who have completed the enrollment process.
- Highest priority goes to returning SCS families.
- Ministry Leaders will continue to follow these [guidelines here](#).

Amount:

- Variable Tuition is not guaranteed. Aid is limited and based on determined financial need and/or available funds.
- Amount may vary from year to year based on family circumstances, funds available, and needs.
- All families are expected to contribute a portion of the tuition.

How to Apply:

- Notify Wendell Geary at [Wendell.Geary@SEChristianSchool.org](mailto:Wendell.Geary@SEChristianSchool.org) of your intent to apply by February 1, 2022.
- Follow the link to FACTS from the SCS website.
- Enter your financial information and complete all required fields.
- Complete the essay question on the FACTS website. We are unable to review your application until the FACTS application form and essay are complete and verified (verification can take up to 10 working days).

Information needed to complete your FACTS application:

- After completing the application, please submit copies of required tax documentation directly to FACTS via mail or electronically. FACTS is a secured site and confidential.
- Payment of your non-refundable \$35 application fee directly to FACTS.

Key Deadlines for the 2022-2023 School Year:

- April 1: Families notify Wendell Geary of intent to apply at [Wendell.Geary@SEChristianSchool.org](mailto:Wendell.Geary@SEChristianSchool.org)
- May 1: 22-23 Enrollment Proposed Budget Set, applications after May 1st will be considered dependent on budgetary restrictions

What is the SCS Tuition decision making process?

- The FACTS online application is reviewed by the SCS Variable Tuition Committee and will be kept confidential.
- Variable Tuition rates are granted based on demonstrated need, family situation, and available funds.
- Applications must be verified by FACTS to be considered for Variable Tuition.

How and when will I be notified?

- Recipients will be notified by Wendell Geary of the committee's decision once all documentation has been submitted to FACTS and processed (10-15 working Days).
